

ARTICLES OF ORGANIZATION

OF

PHANTOM RECORDS, LLC

(A Maryland Limited Liability Company)

Pursuant to Title 4A of the Corporations and Associations Article, Annotated Code of Maryland (the Maryland Limited Liability Company Act), the Articles of Organization of PHANTOM RECORDS, LLC, are hereby duly executed, acknowledged and filed by the undersigned, the person duly authorized to do so, who certifies that:

FIRST: Name. The name of the Limited Liability Company (the "Company" herein) is PHANTOM RECORDS, LLC.

SECOND. The duration of the Company shall be perpetual.

THIRD. Purpose of Company. The purposes for which the Company has been organized and the business and objects to be carried on and promoted by it are as follows:

To engage in the business of entertainment, communications, music composition, music mixing and compilations, digital mastering and remastering, electronic and digital media services, marketing and sales, including production of original compositions and remixed compilations of existing media of all kinds; to provide software and engineering services related thereto; to distribute and sell services and products; to act as an agent, reseller and distributor; and to generally engage in any lawful business or other activity.

The objects and purposes specified herein shall be regarded as independent objects and purposes, and the Company shall be authorized to exercise and enjoy all other powers, rights, and privileges granted to, or conferred upon, a limited liability company of this character by the laws of the State of Maryland, and the enumeration of certain powers as herein specified is not intended as exclusive or as a waiver of any of the powers, rights, or privileges granted or conferred by the laws of the State of Maryland, now or hereafter in force.



SIXTH. Restrictions on Authority. The authority of the members of the Company to act for the Company, solely by virtue of their being members, is limited by a separate written Operating Agreement among the members, as amended in writing from time to time. No member of the Company is an agent of the Company, nor has the authority to act for the Company, solely by virtue of being a member.

SEVENTH. Names of Members. The sole and initial member of the Company is as follows: Michael T. Widener.


